Safeguarding incident	All	<ul style="list-style-type: none"> • Philip maintains up to date Safeguarding Training. • Philip holds an enhanced DBS certificate which is made available to any parent who wishes to see it. • Philip is registered with the Incorporated Society of Musicians and follows the ISM Safeguarding & Child Protection Policy, Code of Practise and Procedures. • Students are not permitted to leave the studio during the lessons unless with a parent/carer. • Parents are encouraged to collect their child(ren) from the studio at the end of each lesson. If a parent wishes for the child to leave the studio alone (ie to meet them in their car on the road) then they must indicate this to Philip in writing before Philip will allow a student to leave the studio unaccompanied. • Toilets are located in the main house and students are escorted by Philip to the toilet if required - see Covid elements below. • Other adults who may be in the house include Anne Anderson (Philip's wife) who also holds an enhanced DBS check. • Philip will maintain a professional dress code at all times. This will be a smart/casual theme, eg trousers and a shirt but no tie. • Communications with students will always be via the parent/carer (unless the student is aged 18+) using the parents' contact details. Lack of first aid supplies / inability to give appropriate first aid	All	<ul style="list-style-type: none"> • A basic first Aid kit is situated in the studio and is well stocked and topped up as required. • Any incident requiring first aid is reported to the parent either during or immediately after a lesson. • An anonymous record of first aid incidents is kept in the First Aid log for ongoing assessment to assist with updating policies or procedures where appropriate. • The nearest defibrillator is situated in the entryway to Treetops Children's Centre, in the grounds of Dursley Primary School at the other end of Third Avenue. This includes raising invoices and logging payments as well as recording expenses. • Philip is a member of the Incorporated Society of Music (ISM) which provide him with Public Liability insurance to the amount of £10,000,000. A copy of his certificate is available on request. • Philip is registered with the Information Commissioner's Office (ICO) as a data controller and has an up to date Data Protection Policy. <p>COVID-19 / known or suspected infection brought into the studio</p>	<p>All</p>	<ul style="list-style-type: none"> • If Philip, or any member of his family, show symptoms or are diagnosed with COVID-19 or produce a positive lateral flow test result, face to face lessons will cease immediately and the family will follow the most up to date government guidelines for self-isolation. • If a student, or any member of their household, shows symptoms or are diagnosed with COVID-19 or produce a positive lateral flow test result, they should not attend their face to face lesson and should follow the most up to date government guidelines for self-isolation. • COVID-19 data trends are continuing to fall according to the government statistics (BBC, Apr 2021). • England was moved into Step 2 of the government's Roadmap out of lockdown (from 12 May 2021) 	<p>Unlikely</p>	<p>Major</p>	<p>Moderate (8)</p>
<p>COVID-19 / 2m distancing compromised</p>	<p>All</p>	<ul style="list-style-type: none"> • Studio size is adequate to maintain individual space at a 2m distance. • Studio has been divided into two areas, one for Philip and one for the student and parent/carer. • Parent information requests families to arrive 5 minutes prior to their lesson and wait in a designated space outside the studio so that, where possible, only one family is moving up the driveway at a time. For situations where this can't be avoided, a one-way system has been implemented to ensure passing families are socially distanced. • First lesson includes discussion on the new safety measures and the reasoning behind these changes. <p>COVID-19 / cross-contamination</p>	<p>All</p>	<ul style="list-style-type: none"> • <u>Limiting access</u>: Only Philip, the student and one parent/carer are permitted in the studio at any one time. Student and parent/carer must remain in the student teaching area. A wipe clean chair is provided for easy cleaning. • <u>Equipment</u>: All students must bring their own instruments (except piano students), music and any required accessories (eg valve oil, mutes, etc.). • Brass students are required to bring an old towel to hold around the water key when emptying water from the instrument. Parents informed to provide a waterproof bag to store towel after use and of suggested washing temperature of 60 degrees. • Music will only be shared digitally (subject to copyright). • The library of books, music, etc. on the back wall of the studio will be covered with a plastic sheet and signs informing students/parents/carers not to touch. • <u>Handles</u>: Only Philip should use the handle to open the doors to the studio. Signs on both sides inform students/parents/carers of this. Cleaning materials available in the event that anyone else touches the door. • <u>Cleaning/Sanitising</u>: The studio music stand, piano, stools and worksurfaces will be cleaned between lessons before the next student enters the room. • Anyone entering the studio is required to use hand santiser on entry. 	<p>Unlikely</p>	<p>Major</p>	<p>Moderate (8)</p>

COVID-19 / cleaning & sanitisation	All	<ul style="list-style-type: none"> Excess items have been removed from the studio to make cleaning easier. <u>Regular cleaning</u> <ul style="list-style-type: none"> Hand sanitiser must be a minimum of 60% alcohol. Music stand, piano, stools and worksurfaces are cleaned between students using antibacterial, disinfectant wipes. Wipes are disposed of into a lined, closed bin and the bin is emptied at the end of each day into the black bag waste. Floor is mopped at the end of each day using antibacterial floor cleaner. <u>Toilet</u> <ul style="list-style-type: none"> If a student uses the toilet within the family home, the toilet & sink must be cleaned before returning to the studio. Attention should also be taken to clean any surfaces the student may have touched, eg handles, light switches, etc. <u>Cleaning after a COVID-19 case</u> <ul style="list-style-type: none"> If a student informs us that they, or a family member, has contracted COVID-19 or has had it within the last two weeks, lessons for that day will be cancelled and the studio will be thoroughly sanitised before lessons resume the following day. The studio will be thoroughly cleaned using antibacterial sanitiser. Gloves and an apron will be worn. 	Rare	Major	Low (3)

First lesson includes discussion on the new safety measures and the reasoning behind these changes.
